Currently, Julia serves as Boston Chapter Vice President for Education, which under her leadership the Boston Chapter was just awarded the National Education Award for Group B at the AGA National Professional Development Conference (PDC) in Nashville, Tennessee. Also, at the PDC, Julia was awarded the Gold Level Award for the Regional Vice Presidents Recognition Program in recognition of her devoted service as the New England Regional Vice President for this past year.

Julia has been with the Commonwealth of Massachusetts for 21 years. Julia has held numerous high level positions in state government. In the early nineties, Julia was the Assistant Commissioner for the Department of Medical Security, where she directed the fiscal affairs for a budget in excess of \$500 million, along with managing the uncompensated care pool accounting, human resources, and information systems.

In the late nineties Julia became the Director of Administration and Finance for the Department of Public Health's, Bureau of Family and Community Health. In this position Julia oversaw the financial aspects of more than 65 accounts in excess of \$249 million and directed the management of over 350 employees.

From 2000 to 2002, Julia was the Executive Director of the Central Business Office for the Executive Office for Administration and Finance, where she oversaw fiscal operations for 15 agencies with budgets in excess of \$383 million.

Most recently, Julia has been the Director of the Quality Assurance Bureau at the Office of the State Comptroller (OSC) where she managed the implementation of the OSC's Quality Assurance Unit. In this position, Julia designed, implemented and evaluated Quality Assurance Review strategy and work plans and directed OSC's reviews of state agencies. Currently, Julia is the Director of the General Accounting Bureau for the OSC, where she is responsible directing the daily activities of the Commonwealth's accounting system.

Julia has been a speaker and panelist on variance internal control topics for numerous organizations, such as, the National State Auditor's Association, National State Auditors and Comptroller's Association, and the Association of Government Accountants.

We would leave home in the morning and play all day, as long as we were back when the streetlights came on.

No one was able to reach us all day. And we were O.K.

We would spend hours building our go-carts out of scraps and then ride down the hill, only to find out we forgot the brakes. After running into the bushes a few times, we learned to solve the problem.

### CGFM NEWS

A Number of questions have been asked about what is the CGFM exam and how do I take it? Here are some of the basics a potential candidate needs to know.

The three comprehensive examinations that make up the core requirement of the CGFM program are:

- Examination 1: Government Environment
- Examination 2: Government Accounting, Financial Reporting and Budgeting
- Examination 3: Government Financial Management and Control

Each of the three separate examinations is structured to require a candidate to demonstrate primarily a general familiarity, understanding and appreciation of the subject area. However, portions of each examination, particularly Examination 2, requires a more detailed knowledge of specific techniques, standards, procedures and practices unique to either the federal government or state and local governments.

The three CGFM Examinations are administered year-round in a multiple-choice, computerized format on behalf of AGA by NetCertification, Inc. via the Prometric Technology Centers. This computer-based administration allows the CGFM Examinations to be offered securely in more than 300 locations in the United States, reducing travel costs and allowing candidates to schedule exams at their convenience.

After purchasing CGFM Examinations online, candidates need to print a Test Authorization Letter. The letter contains detailed instructions on how to schedule a testing appointment at a local Prometric Test Center. Candidates need to arrive at the Prometric Test Center 30 minutes before the appointment time.

Candidates will not be admitted to the testing center without proper identification. Two forms of ID may be required, at least one with photo. The name on the ID must match the registered name exactly. Student identification is not acceptable. Candidates are also required to sign in at the testing center.

No bags, briefcases, etc., will be permitted into the testing facility. No food or drink is permitted in the vicinity of the testing computers. Lockers are available at many testing centers; however, it is suggested that nonessential items be left behind. Candidates should refer to their Test Authorization Letter for additional information on Testing Center Procedures and should bring a copy of the letter to the testing center

Since the CGFM Examinations are administered in a computerized format, test takers receive an immediate pass/fail result (AGA does not provide numerical scores). Most testing centers can also print out the exam result page.

Are you ready to start studying for the examinations? There are several ways to study for the CGFM examinations:

- By attending the instructor led training courses offered in conjunction with *Management Concepts*.
- By purchasing (or borrowing) the new study guides
- By referring to the different reading resources that will help you study for the examinations.

What is the best way to study? The best way to study depends on your knowledge, experience, time and location constraints and individual preferences. Then review each of the choices above to determine which one is best for you.


