## **President's Message**

March is the month that the Boston Chapter of the Association of Government Accountants holds it premier training event the Regional Profession Development Conference (RPDC) that draws government accounting, auditing and financial professionals from all over New England. This year's RPDC is being held on March 9, 2010 at Bentley University in Waltham Massachusetts. We will offer 8 CPE's that will cover the latest information on various financial management topics including new management techniques, advances in technology and practical tips for bringing greater efficiency to government operations. We are truly honored to have knowledgeable and notable speakers and presenters participating in the event. Our morning keynote speakers and presenters) will include AGA's National President Billy Morehead, Ph.D., CGFM, CPA and Executive Director Relmond Van Daniker, DBA, CPA. Billy and Van have a long history of involvement in AGA and both have been active in numerous national AGA committees and boards. Our afternoon keynote speaker will be Middlesex County District Attorney Gerry Leone. District Attorney Leone oversees the prosecution and investigation of hundreds of serious violent crimes in Middlesex County every year, including cases of homicide, child abuse, domestic abuse, and sexual assault.

The Boston Chapter is always interested in new initiatives to enhance government efficiency through various channels such as the AGA's Citizen-Centric Financial Reporting model. We will be hosting a workshop on March 10, 2010 in Boston to highlight this reporting. More details to follow. Many governments struggle to communicate the business of government to residents, particularly when presenting information about how taxpayers' money is allocated and spent. Traditionally, financial information has been presented in forms accessible only to trained accountants. AGA's Citizen-Centric Government Reporting Initiative is intended to foster innovative means of communication between governments and their citizenry. AGA believes that government financial information should be provided to citizens in forms that are clear and understandable, updated regularly and often, delivered to all, easy to locate, honest in breadth and technically accurate in detail. AGA citizen-centric based reports detail government finances in a visually appealing, clear and understandable four-page document. The report shows community information such as population figures, regional characteristics and government goals for the entity. The Boston Chapter supports this important initiative and will be proactive in supporting state, local and federal agencies wanting to pursue this unique financial reporting.

In closing I want to remind everyone that on April 15, 2010 we are holding our spring seminar in partnership with the New England Intergovernmental Audit Forum. The seminar will be held at the Volpe Transportation center located in Kendall Square Cambridge and will offer 7 CPE's. Subject matter will include A-133 updates, Dealing with Difficult Interviewees and Ethics. Please check out the Boston Chapter website for further information and details as the date approaches. The general theory of right action and the greater good is just one of the topics that will be discussed.



This session will include a general discussion of fraud and fraud risk management techniques, examine highlights of the recently-released KPMG Fraud Survey, shed light on the hot topic of social engineering and delve into construction-related topics relevant to the government sector including fictitious vendors, certified payroll, MBE/WBE, bid rigging and fraudulent disbursements





This session will provide an overview of environmental health responsibilities in MA and provide three presentations on recent public health events requiring emergency response. Part one introduces the MA Environmental Public Health Tracking (EPHT) program and will include a live demonstration on the public portal, developed as part of a national effort by the US Centers for Disease Control and Prevention to make environmental health data more available to the public and policymakers for local decision-making. Part two will cover the Bureau's Food Protection Program Rapid Response Team (RRT) which deals with food emergencies that threaten the public health. Finally, part three will involve public health actions taken in response to mercury releases in public schools, including one involving an intentional release.



Auditors have been provided with tools and techniques to assist them in performing their work.

We need to tie in what we learn at each step in the process of planning and executing an audit and to be able to link that information backwards and forwards to strengthen the audit process.

This presentation presents a framework for defining audit objectives and audit criteria in relation to control objectives and control practices, developing audit steps to meet audit evidence requirements, drawing conclusions in line with control objectives, and providing a basis for conducting future audit work.

## **CGFM NEWS**



It is time to renew your CGFM designation and/or AGA membership! Below you'll find answers to frequently asked questions about CGFM renewal:

Q: How often do I have to renew my CGFM designation?

A: CGFM certification is renewed on an annual basis. The invoices are going out in February and the payment is due by March 31st. If you do not receive an invoice by the end of February, please call AGA at 1.800.AGA.7211. You can also renew your CGFM now in the "Members only" section of AGA website (<a href="https://members.agacgfm.org/">https://members.agacgfm.org/</a>).

If your address has recently changed, please be sure to update your contact information with AGA and pay your dues in the "Members only" section of AGA website. If your CGFM is not currently active, please visit <a href="https://www.agacgfm.org/cgfm/maintain/">www.agacgfm.org/cgfm/maintain/</a> for more information on reactivation requirements.

Q: What are the requirements for maintaining the CGFM certification in an active status?

A: To maintain the CGFM certification in an active status, CGFMs are required to:

-- Pay the CGFM renewal fee by the due date every year.-- Complete at least 80 hours of continuing professional education (CPE) every two years in government financial management topics or related technical subjects.-- Maintain and, if requested by AGA, provide detailed information on CPE hours completed.

To retain the CGFM certification, all CGFMs must adhere to the AGA's Code of Ethics. By submitting their annual renewal payment, CGFMs affirm that they have and will continue to abide by AGA's Code of Ethics and that they have fulfilled the minimum CPE Requirements.

Q: How do I determine my CPE cycle?

A: Your first two-year CPE cycle starts on January 1st of the year following the one when your CGFM was awarded (for example, if your CGFM was awarded in 2001, your first CPE cycle was 1/1/02-12/31/03). The award date is listed on your CGFM certificate. Your current CPE cycle is listed on your renewal invoice. Q: My two-year CPE cycle just ended on December 31, 2008, but I did not complete 80 CPEs in 2007-2008. Can I make up the deficiency?

A: Yes. CGFMs who have not completed the 80 CPE hours in 2007-2008 cycle have until March 31, 2009 to make up the deficiency. Any CPE hours completed toward a deficiency in one period must be documented in the CPE records and may not be counted toward the requirements for the next two-year period. Q: I just retired. Do I need to do anything to adjust my CGFM status to "retired"?

A: Yes. Individuals who have permanently retired AND are not working in the field of financial management can request an adjustment of their status to "retired" by contacting AGA's Office of Professional Certification (by mail or e-mail at <a href="mailto:agacgfm@agacgfm.org">agacgfm@agacgfm.org</a> - please provide the date of retirement and confirm that since retiring you have not worked in the field of financial management). CGFMs in retired status are not required to remit the CGFM renewal fee or earn the 80 CPE hours, but must clearly indicate their retired status by using "CGFM-Retired" after their name and using "Retired" or "Retired status" on a resume, bio or other statements of qualifycation.

If retired CGFMs return to work in the field of financial management, they must contact AGA to change their status back to "active."


